Our Mandate: to improve outcomes for St'at'imc and other Aboriginal children on and off- reserve by providing prevention and early Intervention Services and Supports to either prevent or safely return them to care of their parents. Where this is not possible, to find temporary or permanent placements for the children with relatives and/or community members that will be in their best interest.

Child Youth Special Needs (Child & Youth Care Worker)

Desired outcomes: children and youth with special needs experience optimal development, and parents develop skills that allow them to meet their child's needs at home and in the community, allowing them to participate to their fullest in community life.

Family Group Conferencing

The FGC coordinator brings the family and support people together to make plans for keeping children safe who are "at risk" of coming into care.

Aboriginal Supported Child Development
this program will provide resources to families
who have children with special needs to support
the child's inclusion in childcare or
after-school programs.

Child Youth Mental Health Aboriginal Development program

The clinician will provide direct clinical services to children and youth with mental health issues.

The wellness worker will build a mental wellness
network and support the Mental Health
Clinician.
